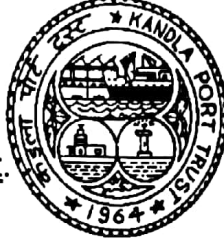



Your Bid dated 22.01.2019 for execution of the work "Fabrication of 01 No. Water Tender Type-B Diesel Cowl Chassis Wheel Base 4225/4300/4330mm including cost of Accessories and Equipments amounting to Rs.29,80,000/- (Rs. Twenty Nine Lac Eighty Thousand only) including all taxes and duties except GST has been accepted subject to terms and conditions appended below and those contained in the Tender Documents and follwing collateral letters :

1) LOA No.MR/WK/1605-II/675 dated 11/06/2019.

## TERMS AND CONDITIONS

- 1) The rate is final including all duties, taxes except GST. GST shall be reimbursed extra as per Tender Conditions
- 2) COMMENCEMENT AND COMPLETION OF WORK :  
The date of start of work will be reckoned from the date of chassis delivered at your work shop. The date of completion will be reckoned on the date of vehicle is delivered back to Deendayal Port Trust. The period of completion in respect of the above vehicle will be 120 days.
- 3) INSPECTION: Stage wise inspections / test of the above Water Tender Type - B to be carried out at fabricator's works by the inspecting officers.

- 4) **MODE OF DESPATCH:** The Chassis will be handed over to Tenderer at his workshop and will be brought to Kandla by Deendayal Port Trust by Road after completion of fabrication, inspection, testing and acceptance etc.
- 5) **TEMPORARY REGISTRATION:** Temporary registration of chassis and fabricated vehicle for the period upto the destination of Kandla – Kutch shall be done by the tenderer
- 6) **CHASSIS :** Chassis shall be supplied by Deendayal Port Trust.  
Diesel Cowl Chassis Wheel Base 4225/4300/4330 mm.

You have to furnish Indemnity Bond for the Chassis and its accessories before the same is handed over for fabrication work.

- 7) **TERMS OF PAYMENT:** 100% (Hundred Percent) payment within 30 days after satisfactory completion of work, delivery of vehicle at Kandla and final acceptance. Since all payments to the Contractor shall be made only through ECS (Electronic Clearing System). Necessary Bank Payment Agreement Form to be furnished along with Bill.
- 8) **GUARANTEE PERIOD:** Guarantee for the satisfactory performance of the vehicle and its allied equipments and accessories shall be for a period of 12 (Twelve) months from the date of delivery. During this period you have to rectify any defects / deficiencies arising out of manufacturing defect, inferior materials/workmanship or faulty materials used at Kandla immediately on receipt of communication from Deendayal Port Trust. The defective parts shall be replaced by your firm free of cost to the satisfaction of Deendayal Port Trust authorities.
- 9) **SECURITY DEPOSIT:** Security Deposit shall consist of two parts; (a) Performance guarantee to be submitted at award of work, and (b) retention Money to be recovered from Running Bills:
- (a) Performance Security shall be 10 % of the Contract Price, of which 5% of Contract Price should be submitted as Performance Guarantee in form of Bank Guarantee, or Demand Draft, within 21 days in case of domestic bids and within 28 days in case of global bids, on receipt of Letter of Acceptance; and balance 5 % to be recovered as Retention Money from Running Bills. Recovery of 5 % Retention Money to commence from the first bill onwards @ 5% of the bill value from each bill. Retention money will be refunded within 14 days from the date of payment of final bill. Balance S.D. will be refunded immediately not later than 14 days from completion of defect liability period.
- b) Failure of the successful Bidder to comply with the requirement of (a) above (i.e. submission of 5 % Performance Guarantee within 21 or 28 days on receipt of L.O.A) shall constitute sufficient grounds for cancellation of the award of work and forfeiture of the Bid Security (i.e. EMD)
- 10) **Income Tax:** The Income Tax shall be recovered from the payable amount of bill as per applicable rules.
- 11) **INSURANCE:** The vehicle should be insured by the DPT in the name of Dy. Conservator, Deendayal Port Trust to cover risk of cost of chassis plus fabrication cost plus Seven personnel including Driver. The Insurance charges will be borne by Deendayal Port Trust.

12) **RESPONSIBILITY:** The tenderer will be fully responsible for any accident, theft, damage to the vehicle when the vehicle is at the works of the Tenderer. In such events the cost as decided by the Deendayal Pot Trust shall be recovered from you. In this connection the decision of Deendayal Port Trust shall be final and binding upon you.

All other terms and conditions as per Tender Document prevails.
