At the outset, Chairman welcomed the Hon'ble Members to the meeting.

Secretary introduced Dr. N. Vinod Kumar, IPoS, Chairperson, Mormugao Port Authority, to the Board, who had been entrusted with additional charge of the post of Chairperson, Deendayal Port Authority w.e.f. 17.04.2024 by the Central Government. The Dy. Chairman & Members present in the meeting extended a very warm welcome to Dr. N. Vinod Kumar and wished him all success.

Secretary informed that this is the first meeting of the Board of DPA for the Financial Year 2024-25 being held on 08.05.2024.

#### I. Leave of absence:-

5. Reimbursement of claims of Port beneficiaries who avail treatment in non-recognized Private Hospitals in life threatening conditions/diseases

However, such claims would only be allowed based on the recommendations of the Doctors' Committee and reimbursement shall be made as per CGHS rates.

- (i) Acute Heart Attack
- (ii) Acute CVA leading to Hemiplegia
- (iii) Life threatening Road Traffic Accidents
- (iv) Snake Bite
- (v) Severe Hemorrhage/shock
- (vi) Coma of any cause
- (vii) Burns more than 30%
- (viii) Acute Epileptic Convulsions
- (ix) Foreign Body in Nose or Throat or severe injury to Eye/Nose/Throat
- (x) Acute Poisoning

- (xi) Any Pediatric Emergency under the age of 5 years
- (xii) Emergency Caesarean Operation
- (xiii) Road Traffic Accidents with communicated Fractures
- (xiv) All types of Cancers
- (xv) If the health condition of the patient is deteriorated suddenly and may claim the life of the patient, if the treatment is not provided in emergency
- 6. Declaration of rate of interest on Deendayal Port Authority Provident Fund balance for the year 2023-24.
