**Name of work :-** "ISO 14001 certification for providing port facility and related maritime services for vessels and Cargo Handling including storage for the period of 3 years

1. An attested copy of valid accreditation as an ISO certification body may be attached with the bid
2. The contract period is 3 years from the date of issue of work order.
3. Bidders may note that DPA will not entertain any deviations to the bid document at the time of submission of the Bid or thereafter. The bid to be submitted by the bidder will have to be unconditional. Any conditional bid shall be regarded as non-responsive and would be liable for rejection.
4. No change in, or supplementary information to a bid shall be accepted after last date of submission of bid. However, DPA reserves the right to seek additional information from the bidder if found necessary, incomplete submission or delayed submission of such additional information or clarification sought by DPA, may be ground for rejecting the bid.
5. The currency for the purpose of the bid shall be the Indian Rupee (INR)
6. DPA reserves the right to reject any or all of the bids without assigning any reason whatsoever.
7. DPA reserves the right to invite revised proposals from bidders with or without amendment of the bid at any stage, without liability or any obligation for such invitation and without assigning any reason.
8. Support from DPA
  - i. The DPA will provide facility such as training Centre projector for conducting training and discussion related to during internal audit and surveillance audit transportation from A.O building, Gandhidham, Kandla and Vadinar to different offices of DPA, will be provided by DPA.
  - ii. Any other cost facility related to scope of work will be borne by successful bidder
