- The scope of work includes Providing, fixing and removal of Decorative Series lights at Chairman Bungalow (1 no.), Dy. Chairman Bungalow (1 no.), HoDs Bunglow (A-type 7 nos.), Dy. HoDs Bunglow (6 nos.), Gopalpuri Guest House, Gopalpuri Hospital, Entry Gate of Gopalpuri Colony, series lights on trees round the sports complex, AO Building with its gate and Kandla North Gate on hiring basis on eve of Diwali Celebrations & subsequent new year.
- The series lights should be of good quality and the Contractor shall ensure that same does not diffuse during the days of celebration.
- The series lights are to be fixed from 31/10/2024 to 04/11/2024 (It should be lighted from 30th evening). Same may be removed on or after 05/11/2024.
- The series lights should be in various colours as per requirement and as directed so as to brighten the areas appropriately.
- The lighting shall be sober looking & attractive.
- The contractor shall monitor the entire lighting system during the above period and in case of failure of any one, the same shall rectified/replaced immediately.
- The work is inclusive of loading, unloading, transportation, to & fro work place to bidder's Godowns.
- Lighting related all accessories like DBs, Wires, Cables, MCBs, etc. are in the scope of the contract.
- All the safety parameters shall be taken by the contractor during execution of work.
