(Financial turnover document to be CA certified with CA's stamp, signature and UDIN no./ membership no. along with profit &amp; loss statement for verification of turnover failing which the bid will be treated as non-responsive)</p> <p>(ii) <u>Experience</u>: Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:</p> <p>(a) Three similar completed works each costing not less than the amount equal to <b>Rs. 9.79 Lakhs</b></p> <p><u>OR</u></p> <p>(b) Two similar completed works each costing not less than the amount equal to <b>Rs. 12.24 Lakhs</b></p> <p><u>OR</u></p> <p>(c) One similar completed work costing not less than the amount equal to <b>Rs. 19.57 Lakhs</b>.</p> <p>“Similar work” means “ any civil construction / renovation / maintenance work” constructed during last 7 years ending last day of month previous to the one in which applications are invited. If the bidder has executed the work in private organization, necessary TDS certificate issued by the private organization shall be submitted. If the similar work is executed as sub-contractor, it is mandatory to upload the sub-contract permission letter obtained from the Govt./ Public sector, or from the owner of the project in case work belongs to private organization.
