

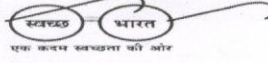
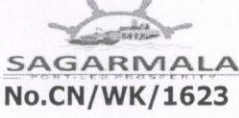

Sub: "Development of Storage Yard in the five(05) hectares area at Hazira RoRo/RoPax facility."

Sir,

Deendayal Port Authority (DPA) is in line with its continued initiatives for implementation of various Projects for developing RoRo-Ferry facilities at Hazira, Dahej, Ghogha, Muldwarka, Pipavav in Gujarat State. DPA has already developed Terminals comprising with all facilities, such as, waiting room, administration office, Sub-Station, Jetty, Link span, Pontoon, etc at Hazira, Ghogha, Dahej, and is under process of developing the above facilities at Muldwarka, Pipavav. Further, DPA has already commenced the RoRo/Ro-Pax operations between Ghogha to Hazira.

DPA now intends to explore the possibility of development of Storage Yard in the five(05) hectares area out of the total 19 hectares vacant backup area at Hazira RoRo/RoPax facility. The land shall be allotted on lease basis for the period of 10 years extendable upto another 5 years. The land shall be exclusively developed as container storage yard for facilitating the container traffic through RoRo/RoPax facility at Hazira. The Location layout of the terminal is attached herewith for reference.
