Madam / Sir,

Reference our Vacancy Circular No. GA/PS/CME/2024/4486 dated 24.10.2024 for filling up the post of Chief Mechanical Engineer in Deendayal Port Authority by absorption through Composite Method.

Applications are invited for filling up of the post of Chief Mechanical Engineer in Deendayal Port Authority, in the scale of pay of Rs.1,00,000-2,60,000 (pre-revised Rs.18500-23900), by absorption through composite method from the eligible and willing officers of Major Port Authorities, fulfilling the eligibility criteria prescribed in the Recruitment Rule for the said post.
