Conducting Studies on Dredged Materials for the presence of Contaminants. The study will cover sampling and analysis of 36 marine water samples and 18 marine sediment samples from three dumping locations per season for three seasons in a Year. Samples will be characterized for Physical, Chemical and Biological nature to understand the impact of dredged materials in and around the dumping locations.

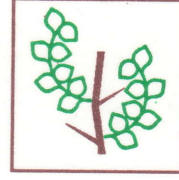

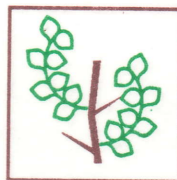

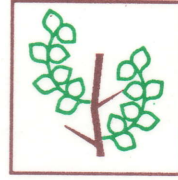
