- The series lights should be of good quality and the Contractor shall ensure that same does not diffuse during the days of celebration.
- The work shall be planned and executed in a such way to complete the same in all respect latest by 31.10.2024. The removal work shall be started from 05.11.2024.
- The series lights should be in various colours as per requirement and as directed so as to brighten the areas appropriately.
- The lighting shall be sober looking & attractive.
- The contractor shall monitor the entire lighting system during the above period and in case of failure of any one, the same shall rectified/replaced immediately and for that a technician should be present at the site with the vehicle.

- The contractor shall execute the work in such a way that not to cause inconvenience to the public or staff or nearby quarters/offices and not to cause hindrance to traffic.

 Necessary barricading shall be done by the contractor at his own cost if required.
- All tools, plants, scaffolding ladder etc. and other machinery etc. required temporary for the purpose of execution of work will have to be arranged by the contractor at his own cost and storing of such tools, plants etc. will have to be made by him.
- The GST Registration No. & PAN No. should invariably be mentioned in the Quotation, failing which the Quotation will be considered as non-responsive and be liable to discharge.
- 15 | Force majeure: This will be restricted to natural calamities and acts of GOD only.

16 Taxes and GST:

"Contractor/service provider/supplier etc. has to ensure timely and proper filling of GSTR 1 so that Deendayal Port Authority can avail input tax credit in timely manner. In case DPA not allowed input tax credit due to failure on part of the contractor/ service provider / supplier etc., it will be a financial loss to the DPA and therefore same shall be recovered from the payment/deposit of the contractor/service provider/supplier.

GST Clause:

The contractor shall quote the price exclusive of GST. The applicable GST shall be paid extra to the contractor after producing GST Invoice as per the certified Bill by the department. However, element of GST shall not consider for evaluation of bid. 'Contractor/service provider/ supplier etc. has to ensure timely & proper filling of GSTR 1 so that Deendayal Port Authority can avail input tax credit in timely manner. In case DPT not allowed input credit due to failure of part of the contractor/ service provider/ supplier etc., it will be a financial loss to DPI & therefore same shall be recovered from the payment/ deposit of the contractor/ service provider/ supplier.

TDS ON GST:

TDS provision under GST Acts, 2017 are in force from 01.10.2018 and accordingly TDS under GST Act will be deducted @ 2 % (1% CGST and 1 % SGST or 2 % IGST) from payment / credit give to contractor / contract / professional and other for work order / contract exceeding Rs. 2,50,000/-.

Deduction of Income-Tax and GST:

Income-Tax deductions and surcharge and GST+TDS provision under GST Act as applicable thereon shall be made good while making payments due to the contractor for carrying out the work and only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.

Tax:

The rates quoted (except GST) by the contractor shall be deemed to be inclusive of the taxes, duties etc. which the contractor will have to pay for the performance of this contract. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.

- 17 EMD of the bidder other than L-1 & L-2 will be released within seven days from date of opening of quotation. EMD of L1 & L2 bidder will be released after commencement of work by L1 bidder.
- 18 All the rules & regulation governing D.P.A. will be applicable.

19	In case of the work is not completed in all respect by 31.10.2024 then the penalty of Rs. 10,000/-per day will be levied. Also if any of the lightings does not work or rectified within half an hour of
	raising of complaint then a penalty of Rs. 2000/- per complaint per hour will be levied.
20	The contractor shall not deposit any materials at such a place, that may cause inconvenience to
	the public or staff or nearby offices.
21	The Contractor shall ensure not to cause any damage to the port properties in the vicinity of work
	site during execution of work. If any damage occurs due to workmen / machinery of the contractor, the contractor has to make good the loss / damage at his cost.
22	The contractor shall affix SEAL along with SIGNATURE in the quotation, failing which the
	bid/Quotation will be consider as non-responsive and liable to discharge.
