TERMS AND CONDITIONS

- 1. The subject work is for refurbishment of the road weighbridge no.14 and 15 situated inside cargo jetty area, Kandla.
- 2. DPA is intend to carry out the refurbiushment work of two numbers road weighridges i.e. WB-14 & 15 situated inside cargo jetty area. However, DPA at his discretion shall change/alter the refurbishment work of weighbridges instead weighbridge no.14 and 15 before the commencement of work.

- 3. The agency, at his own responsibility, risk and cost is encouraged to visit and examine the said weighbridge and its surrounding for complete understanding of work.
- 4. The broad scope includes dismantling of weighbridge structure and its members, replacing complete old platform plates by new plates (provided by DPA), dimantling existing old girders & fitting of 45 nos. new ISMBs with proper resting packings, epoxy painting work of complete structure after surface preparation by wire brush/power brush, replacement of existing old load cells by the new digital load cells with base plates & holding plates after required associated minor civil work, supply & installation of compatible IT kit, junction box, heavy duty HDPE corrugated conduit pipe for securing cables, re-installing & alignment of complete weighbridges structure & load cells, providing excess movement restrictors/stopper at appropriate locations, connections of the all components, commissioning of the complete system and verification & certification from Legal Metrology Department.
- 5. The shifting (including laoding & unloading) of the old material/scrap genarated from the work to the DPA's Main Store Kandla after completion of work shall be in the scope of the contractor. The DPA shall provide pickup/tractor trolley for shifting of the old material/scrap as per availability.
- 6. The specification of the 08 nos of **Digital Load Cell** supplied shall be, **Load Cell**: **Digital Type**, **Make**: **Appalto**, **Capacity**: **30T**, **Model No.**: **ACB-D30t**, **Accuracy Class**: **C3**, **Protection**: **IP 68 or higher**, **Confirming to OIML-R60.** Digital load cell shall be supplied with the **Integral armoured cable**.
- 7. One number of Intelligne Terminal Kit Compatible with the Digital Load Cell and Junction Box compatible to accommodate 08 no. of digital load cells & harsh environmental condition.
- 8. Only required steel plates for platform will be provided by DPA. All other material including 45 nos. of ISMB 250 X 125 (Preferable Make: SAIL/TATA/JINDAL) for each weighbridge etc. to complete the work shall be in the scope of the agency.
- 9. Sucessful agency has to handover the weighbridges in complete commissioning state including stamping certificate witin the stipulated time period.
- 10. Agency shall hold the valid repairer license issued by Legal Metrology.
- 11. The agency at its discretion may complete the work at site or at his workshop.
- 12. Necessary statutory fees payable to the Legal Metrology Department will be borne by the Agency.
- 13. The work shall be completed within 25 days from the date of issue of work order including stamping. Successful agency has to immediately complete the procedures for issuing the gate pass from CISF on his own cost.
- 14. Liquidate Damage: In case of delay in completion of work, liquidate damage (LD) shall be levied @0.5% per week or part thereof, subject to the maximum of 10% of the work order value.
- 15. The work order will be issued to the agency who quotes lowest amount.
- 16. All the Rules & Regulations governing Deendayal Port Authority will be applicable.

- 17. **Defect Liability Period:** The warranty period shall be valid up to six months for the refurbishment work with effect from the date of completion of the work. The warranty period of twelve months with effect from the date of completion of the work will be applicable to the supplied materials Digital Load Cell, Intelligent Terminal Kit, Junction Box. If any defects occur within the stipulated period of warranty/guarantee period in supply items, the same shall be made goods/replaced by the agency without any extra cost to DPA. The agency has to furnish undertaking in this regard.
- 18. The Performance Guarantee/Security Deposit equal to 10% of the work order value shall be applicable. Out of which 5% SD shall have to be submitted by the bidder and 5% SD shall be recovered from the First and Final Bill. The same shall be refunded not later than 14 days from completion of defect liability period of 12 (Twelve) months.
- 19. The complete responsibility for safe working of their staffs will be borne by the Agency. DPA will not be responsible for any loss, damage or accident to any of the staff.
- 20. The rates quoted shall be inclusive of all labour, materials, loading, unloading, certification of verification duties, taxes, levies, Transportation, tools, tackles, jigs and fixers etc. Except GST and no extra payment will be made for whatsoever reasons by Deendayal Port Authority.
- 21. The Agency shall quote the price exclusive of GST. The Contractor shall quote prevailing GST rate separately. GST shall be paid as per actual at the time of release of payment. All other duties, taxes, cess applicable, if any, shall be borne by the Contractor.
- 22. The payment shall be released, through RTGS/NEFT after completion of the work including its certificate of verification issued by the Legal Metrology Department within 30 days for which party has to submit the invoice and bank details also in triplicate. The bills must have GSTIN No. of the party (if registered under GST) as well as GST No. of DPA (GSTIN No. of DPA is 24AAALK0046N1Z6).
- 23. Income tax/Education cess as applicable shall be deducted at source.
