
The bidder shall provide attested copies of following documents:-

- Certificate of registration viz. company, partnership firm or proprietorship firm;
- Completion certificate for consultancy work for atleast 3 agencies which have successfully received the ISO 9001:2008/2015 certification during the last three years from 01/04/2021.
- Certificate for professional experience of atleast two years of Team Leader alongwith certificate of ISO 9001:2018/2015 as lead auditor with accreditation certificate from IRCA or

BABET, and Certificate of professional experience of atleast two years of co-team leader of the consultancy team proposed by the bidder;

- d. The bidder shall have atleast three persons (excluding the team leader and co-team leader) having experience of working in ISO 9001:2008/2015 consultancy works. The bidder should furnish the details of experience and furnish evidence to support its claim;
- e. Copy of Income Tax PAN Card of the firm;
- f. Copy of GST registration number;
- g. MoA (Memorandum of Association) or AoA (Articles of Association) in case of company, partnership deed in case of partnership firm, affidavit in case of proprietary firm or registration of firm document as proof of the existence of the bidding company;
- h. Certificate from Chartered Accountant about achieving an average annual turnover from consultancy and audit services for Quality System, of atleast Rs.0.45 lakhs in the last three financial years;
